SECTION C: DONATIONS

SECTION D: BEQUESTS

Leaving a bequest in your Will gives you the satisfaction of knowing that you will continue to support the values that drive you well into the future. A bequest may be unrestricted or designated to a particular aspect of the Foundation's program. Different types of bequests options are available, including specific, percentage or residual bequests. You may also choose a contingent bequest or testamentary trust. When determining the type of bequest you would like to choose, and how to make that choice clear in your Will, professional advice could prove helpful in assisting you to make those choices.

Wording for making an unrestricted bequest
